DISCUSSION	<p>Julie reported that she has been in touch with Sarah Jane Geraldi with the Colorado Child Care Assistance Program (CCCAP) regarding how technical assistance can be provided to our counties to provide outreach and determine how funding can be used in our communities. Sarah Jane will be reaching out to our DHS Directors. The state has a goal that there should be one CCCAP child with each L2 or above rated provider.</p> <p>CKLECC has been funded by the Buell Foundation for another year. A portion of the funding goes towards the Fun Tote Program. If there are new organizations who would like a set of totes they just need to let Julie, Haley, or Candace know.</p> <p>Carole Spady can now offer Face to Face trainings to providers. She will be working on getting dates set up over the course of the next couple of months.</p> <p>Julie will be forwarding out a link to the entire group regarding the public comment period for Early Childhood Council rule change proposals.
